The TRASH FLOW Off-Site Back-Up software can make backups at preset times, or on demand, even while TRASH FLOW is in use. It also provides its own restore process. A live Internet connection is required, and DSL, Cable or faster is recommended. This service is available for \$120 per year (must be renewed prior to expiration to avoid interruption) OR for \$10 per month if you agree to automatic, monthly, electronic payments.
